EXPULSION OF STUDENT CASE #0002

Director Imming stated after the Board's consideration of the evidence presented in the matter of the recommendation to expel Student Case #0002, the Board adopts the findings of fact set out in the Administrative Advisory Council, and the Board concludes the student violated the regulations and rules established by the Board and the continued presence of the pupil is detrimental to the best interest of the school:

MOTION: Director Imming moved that after the Board's consideration of the evidence presented in the matter of the recommendation to expel Student Case #0002:

1. that Student Case #0002 be expelled from the Davenport Community School District for the remainder of the 2000-2001 school year;
2. that Student Case #0002 will not be allowed on any Davenport Community School District property or be in attendance at any school event where a Davenport team is participating during the time of the expulsion other than the site of the alternative programming;
3. that Student Case #0002 will receive services at the Harrison Street Program for the remainder of the year;
4. that prior to the beginning of the 2001-2002 school year, the Administrative Advisory Council will meet to determine appropriate placement for Student Case #0002.

Director Lee seconded the motion.

The vote on the motion was called and recorded as follows: Ayes, Imming, Lee, Hunter, Howard, and Hester. Motion carried unanimously.

EXPULSION OF STUDENT CASE #0003

Director Howard stated after the Board's consideration of the evidence presented in the matter of the recommendation to expel Student Case #0003, the Board adopts the findings of fact set out in the Administrative Advisory Council, and the Board concludes the student violated the regulations and rules established by the Board and the continued presence of the pupil is detrimental to the best interest of the school:

MOTION: Director Howard moved that after the Board's consideration of the evidence presented in the matter of the recommendation to expel Student Case #0003:

1. that Student Case #0003 be expelled from the Davenport Community School District for the remainder of the 2000-2001 school year;
2. that Student Case #0003 will not be allowed on any Davenport Community School District property or be in attendance at any school event where a Davenport team is participating during the time of the expulsion other than the site of the alternative programming;
3. that Student Case #0003 will receive services at the Harrison Street Program beginning Second Quarter of the 2000-2001 school year;
4. that prior to the beginning of the 2001-2002 school year, the Administrative Advisory Council will meet to determine appropriate placement for Student Case #0003.

Director Imming seconded the motion.

The vote on the motion was called and recorded as follows: Ayes, Howard, Imming, Hunter, Lee, and Hester. Motion carried unanimously.
