4:53 PM EXPULSION OF S. B.

Director Low stated after the Board's consideration of the evidence presented in the matter of the recommendation to expel S. B., the Board adopts the findings of fact set out in the Administrative Advisory Council, and the Board concludes the student violated the regulations and rules established by the Board and the continued presence of the pupil is detrimental to the best interest of the school:

MOTION: Director Low moved that after the Board's consideration of the evidence presented in the matter of the recommendation to expel S. B.:

1. that S. B. be expelled from the Davenport Community School District until the end of the third quarter of the 1999-2000 school year;
2. that S. B. not receive alternative services during the time of his expulsion;
3. that S. B. will not be allowed on any Davenport Community School District property or be in attendance at any school event where a Davenport team is participating during the time of the expulsion;
4. that prior to the beginning of the fourth quarter of the 1999-2000 school year, the Administrative Advisory Council will meet to determine appropriate placement for S. B.

Director Imming seconded the motion.

The vote on the motion was called and recorded as follows: Ayes, Low, Imming, Howard, Hester, and Hollonbeck. Motion carried unanimously.
